**Minutes from the July Meeting:**

The meeting of the Knights of Columbus Council 4902 was called to order by Grand Knight Joshua Sazama at 7:00 pm. Mark Moelter read the June meeting minutes and the council voted in approval of the minutes as read. Doug Weiss read the bills and the council approved paying of the bills.

District Deputy, Mike Fraise discussed the upcoming District meeting which will be held on July 30, 2015 7:00 pm at St. Patrick's in Hudson, WI. The district Officer Installation will be August 20<sup>th</sup> in New Richmond. The officer installation begins at 7:00 pm and wives are invited to attend the ceremony. Mike also mentioned the State goal is to have one degree/district/month. Council 4902 is scheduled to have a 1<sup>st</sup> Degree in August, November, and March.
